Bandy Creek

The National Park Service is striving to serve the public at the Bandy Creek Campground in the Big South Fork NRRA. Enjoy your stay with us and please let us know if we can do anything to make your stay more enjoyable.

Rules and regulations are established under the authority of Title 36, Code of Federal Regulations. Their purpose is to protect you, your property, the parks resources, and to eliminate inconvenience to other visitors.

GENERAL



Please register at the entrance station once you have selected your campsite. Fill out the envelope, enclose your camping fee and deposit the envelope in the collection box. Remember, no refunds will be given.

Horse back riders wishing to rent a stall will find the envelopes and a collection box located at the stables. Camping fees are due in advance each day prior to 12 noon. Sites not paid for after 24 hours will be cleared of equipment.

Golden Age and Golden Access passports are honored.

TO PROTECT YOU AND YOUR PROPERTY.

The Bandy Creek Campground is open to paid campers and their guests. Within the safety zone (BLUE BLAZE), camping is limited to designated sites.

Campground quiet hours are from 10:00 p.m. to 6:00 a.m.

Campsite limitations shall consist of one family or no more than five individuals, and not more than one recreational vehicle and one tent. A maximum of two vehicles is allowed per site and no vehicle is to be parked in a manner which interferes with normal traffic. Trailers and recreational vehicles can not exceed 35 feet in length.

Alcoholic beverages can be used within the Recreation Area in accordance with State law. An open container of an alcoholic beverage cannot be carried or possessed in the passenger compartment of motor vehicle which is on a park road or in a designated parking area.

Place your garbage in the furnished bag, tie it closed and place in dumpster. Empty sewerage at dumping station and dishwater in toilets. NOT ON THE GROUND.

For your safety, all vehicles operated in Bandy Creek Campground must be operated by licensed drivers, be registered and be street legal.

Within the Bandy Creek Campground, horses must use corrals, stables or horse trails. Horses are not allowed on paved roads, hiking trails or in the campground.

All pets must be restrained on a leash which shall not exceed six feet in length.

Power saws may not be used in the campground.

Do not trench, dig, or level the ground at your campsite.

Using or possessing fireworks is prohibited. Bicycles are not permitted on foot trails. They may be used on horse trails and all roads.

Use the lantern holder in your campsite. Do not cut limbs or drive nails into trees.

Dead wood on the ground may be collected for use as fuel for campfires. Build your campfire only in designated areas or receptacles and make sure all fires are out before you leave. Do not leave fires unattended.

Traps, nets and unloaded weapons may be possessed within a temporary lodging or mechanical mode of conveyance when they are rendered temporarily inoperable, or stored in a manner which will prevent their ready use.

Telephones are located in Loop "A", at the campstore, and at the Leatherwood Ford Bridge AFTER HOURS DIAL "O" and ask the Operator for the Scott County Sheriff's Dept. Ask the Sheriff to contact a National Park Ranger. Tell him what is wrong and where you are calling from.
