PRESIDENTS MESSAGE TO PLEA





PARK POLICE PLACE IN LAW ENFORCEMENT CHALLENGE PROGRAM

The Crystal Lake Park District Police Department was recently named a winner in the International Association of Chiefs of Police (IACP) and the Illinois Association of Chiefs of Police Law Enforcement Safety Challenge Program. The Crystal Lake Park District Police received 3rd place at the National Level in the Special Enforcement Division. The Illinois Association of Chiefs of Police and Illinois Department of Transportation (IDOT) judged the Park District Police program at the state level first. At the state level the Park Police placed 1st in the special police division and 2nd place for Rookie of the Year. The rookie of the year award is for agencies that apply for the award for the first time regardless of agency size. The Law Enforcement Challenge is a competition between similar sized and types of law enforcement agencies. It recognizes and rewards the best overall traffic safety programs in the United States. The areas of concentration include efforts to enforce laws and educate the public about occupant protection, impaired driving, and speeding. The winning safety programs are those that combine officer training, public information, and enforcement to reduce crashes and injuries within its jurisdiction.

This program is financed through a grant awarded to the IACP by the National Highway and Traffic Safety Association (NHTSA). IACP and NHTSA believe an increase in traffic enforcement in a community results in a decrease in motor vehicle crashes, injuries, and fatalities. In fact, no single other program, or strategy, works as well as law enforcement in making the roads safer. This program complements all the other training and public information programs that NHTSA does to promote traffic safety.

A panel of three judges reviews each application and assigns points based on the criteria. After the judging, the three scores are averaged and a final score is assigned. After all of the applications are scored, the agencies are ranked in their categories. All judges are independent members of the law enforcement community, public safety and corporate partners who have demonstrated advance knowledge of highway safety initiatives.

Congratulations to Chief Ron Lyons and his officers for a job well done.

The 2006 Winter Retreat was held on January 8th and 9th at the La Quinta Inn in Peru Illinois. Attorney Steve Kleinman (PDRMA) JD, PDRMA General Counsel, presented an informative training session. The training session presented was "Common Hiring, Discipline, and firing Myths, Misperceptions, and Pitfalls".

2006 IPLEA SPRING WORKSHOP

The 2006 IPLEA Spring workshop was hosted by the Forest Preserve District of DuPage County (FPDDC) Police Department on April 10, 2006. The Workshop training was conducted after the April IPLEA Board meeting at the FPDDC Headquarters in Wheaton, Illinois. Seventeen park law enforcement professionals from eight different agencies attended the training session and contributed to the workshops success. FPDDC Master Firearms Instructor Tony Jaconetti conducted the training entitled "The Value of the Rifle Carbine in the Law Enforcement Setting." The comprehensive training session summarized the FPDDC



Police Department's development of its rifle program and was very informative for all of the attendees that were in various stages of rifle program development. A thorough hand-out was distributed to all of the attendees that contained valuable rifle program information including: budget and equipment data, training requirements, policy development, ballistic and statistic information, ways to obtain equipment, and legal and law enforcement information. Workshop attendees were also able to peruse several tables displaying numerous weapons used in law enforcement, military, and criminal scenes.

LEGISLATIVE UPDATE SUMMER 2006

Introduced/Pending:

S 2629 Anti-Gun Trafficking Penalties Enhancement Act

Sponsor: Senator Schumer (D-NY)

A bill to improve the tracking of stolen firearms and firearms used in a crime, to allow more frequent inspections of gun dealers to ensure compliance with Federal gun law, to enhance the penalties for gun trafficking, and for other purposes.

S 2831 Free Flow of Information Act of 2006

Sponsor: Senator Lugar (R-IN)

A bill to guarantee the free flow of information to the public through a free and active press while protecting the right of the public to effective law enforcement and the fair administration of justice. The bill would provide added protection to journalist's sources.

HR 4709 Law Enforcement and Phone Privacy Protection Act

Sponsor: Rep Smith (R-TX)

A bill to amend title 18, United States Code, to strengthen protections for law enforcement officers and the public by providing criminal penalties for the fraudulent acquisition or unauthorized disclosure of phone records.

Judicial:U.S. Supreme Court-Garcetti v. Ceballos

05/30/06 Case # 04-473

When public employees make statements pursuant to their official duties, they are not speaking as citizens for First Amendment purposes, and the Constitution does not insulate their communications from employer discipline.
