

NARRATIVE DESCRIPTION OF RESOURCE

Brady's Cattle Mound, HS-08

A 6-to-7-foot-high-by-300-foot-circumference, oval-shaped earthen mound located

[REDACTED] The mound is covered with high grass, but no trees grow on top of the mound because of its continued use. The current owner constructed a chain link fence and wood door hog trap on top of the mound. The mound retains a high degree of location, design, setting, materials, workmanship, feeling, and association integrity.

NARRATIVE STATEMENT OF SIGNIFICANCE

Brady's Cattle Mound is significant under the context "Agricultural Settlement in the Congaree Swamp: 1740-1900" established in the National Register of Historic Places Multiple Property Documentation Form for the *Historic Resources of Congaree Swamp National Monument*. Free-ranging livestock provided a significant source of food and income prior to the Civil War in the South Carolina back country. Settlers in the Congaree Swamp constructed cattle mounds to provide a place of refuge for hogs, cattle, and other grazing animals during the flood season. Brady's Mound was constructed circa 1900 and continues to be used for its original purpose.

The cattle mound is significant at the state level under National Register criteria A and D for its association with the agricultural settlement of the Congaree Swamp and for its ability to yield information about settlement patterns in the region.
