# From the Superintendent

On AUGUST 25, 1916, President Wilson signed the Organic Act creating the National Park Service, a federal bureau in the Department of the Interior. On August 25th, 2016, just four short years from now, the National Park Service will celebrate its 100th anniversary.

Last summer Director Jon Jarvis issued a call to all National Park Service employees and partners to commit to actions that advance the Service toward a shared vision for our second century. Women's Rights National Historical Park is up to this challenge.

Here are some of the actions we are embracing as we continue to protect resources, serve as an inspiration, and be relevant for the communities we are honored to serve.

#### Action item #10- ARTS AFIRE!

The park will showcase the meaning of parks to new audiences through artist-led, multi-day park workshops which cultivate a deeper understanding of the park's historic resources through creation of art through poetry, collage, cyanotype, and landscape painting. Park visitors will have direct interaction with park staff, create artwork inspired by the park experience, and share their artwork on the nps.gov website and in the park's gallery in the Visitor Center.

#### Action Item #12- Follow the Flow

The park will work with partners to try to develop a water trail that will connect Continued on page 2

## ARTS AFIRE! Brings M'Clintock House to Life

Imagine a quiet, empty historic house, open only in summer months. Consider a partnership between organizations with very different missions and strengths. Invite local citizens into the house to learn about the stirring events that happened there and to turn their learning into poetry and art with the coaching of master artists. Hear their voices and laughter fill the house. Picture them reading their poems and describing their collages in a public event and displaying their work to the public.

This March, ARTS AFIRE!, a cosponsored project of the Seneca County Arts Council and Women's Rights National Historical Park, filled the Thomas and

park resources such as the M'Clintock house, Visitor Center, Wesleyan Chapel, and the Elizabeth Cady Stanton House to other public lands and green spaces such as the US Forest Service and the US Fish and Wildlife Service through human powered, water borne transportation. This will allow visitors to the Finger Lakes to recreate, appreciate the natural environment, and learn about the First Women's Rights Convention in an enjoyable and environmentally responsible manner.

#### Action item #15- A Class Act

The park will be working with the local classes of 2016 over the next four years to help them develop an understanding of park resources and the relevance of the parks in their lives.

#### Action Item #17- Go Digital

The park will continue to bring our resources and information to the public through our website, social media sites (Facebook and Twitter), an upcoming museum artifact web-catalog, a free "Application" for smart phones available through iTunes, and a cell phone tour. We want information about our park available to everyone no matter where they are located geographically.

#### Action item #19- Out with the Old

We are updating our publications, brochures, exhibits, and signs so the content is current, reflects recent scholarship, and the layout is aesthetically pleasing.

#### Action item # 23- Go Green

We are looking at ways to be more environmentally conscious by using less energy, recycling products and equipment in responsible ways, buying green-products, and doing everything we can to get closer to carbon neutrality.

#### Action item #31- Play it Safe

We are committed to making the park safe for all visitors, volunteers, and

and packets of historic documents and photos, participants went to work to capture the house, the family, and the struggles for freedom and equality in which the M'Clintocks played an essential role. Poetry written with the help and instruction of Patricia Roth Schwartz and collages created under the direction of Lynn Patti brought the M'Clintocks and their home back to life.

Participants of the inaugural ARTS AFIRE! program include Ginny DeJohn, Marti Houseknecht, Margaret McComb, Lucinda McWeeney, Roberta Nelson, Barbara Quinn, Ann Ricci, and Chris Swanson. SCAC members Lynn Patti and Patricia Roth Schwartz were the first teachers. An exhibit featuring works by Patti and Schwartz, including all the art and poetry produced during the M'Clintock workshops, is on display in the park visitor center through April.

One participant wrote "Thank you for enabling all of us to be part of this really unique learning experience....I am very proud of our Parks Program!" We are proud of our partner, the Seneca County Arts Council, and of the wonderful work

## Farewell to the Suffrage Press

A special program and reception was held to bid farewell to the suffrage printing press on Saturday, February 18.

The printing press, which was acquired from Helaine Victoria Press in 1994, was used by Women's Rights National Historical Park for educational, living history, and special programs. It also provided interpretive products such as postcards for park programs. Though the printing press itself does not date back to the First Women's Rights Convention that was held in 1848, it was dubbed the "suffrage press" because it highlights the powerful role of the media in spreading the message of the early women's rights movement.

Changing visitation patterns and staffing needs led to the reduced use of the print

shop by 2009. However, a local partnership will provide a new opportunity for the press to be used to educate the public about the power of words to change society.

The press has been moved from its Fall Street location to Three Stories/Art Industry Opportunity, Inc., in Geneva, NY, where it will be used in book arts and other programming.

"We are thrilled to find a local partner whose passion for history, for printing, and for the power of people to transform society will bring this equipment to new life," said Superintendent Tammy Duchesne. "We look forward to partnering with Three Stories to promote the role of printing in the women's suffrage movement."

## Park Expands Brochure Offerings to Include Braille

Nearly 300 million people are expected to visit America's National Parks this year, and the National Park Service has made a commitment to ensuring that everyone has the opportunity to enjoy the natural and cultural wonders that abound at its 397 sites. As part of this effort, Superintendent Tammy Duchesne announced that the park's site brochures are now available in Braille.

Visitors to Women's Rights National Historical Park who are visually impaired may request Braille brochures from a park ranger. The brochures provide detailed information about the First Women's Rights Convention that was held in Seneca Falls, the Convention organizers, the Wesleyan Chapel where the Convention was held, and the park's famous statue exhibit.

"I am extremely proud that we are working our way towards one day being programmatically and physically accessible to all audiences. This park stands

### Burn While You Learn! Map Now Available

The park's Healthy Parks, Healthy People committee - or HP-squared, as it's affectionately referred to by the staff - has completed a "Burn While You Learn" map that will allow visitors to get fresh air and exercise as they walk in the footsteps of Elizabeth Cady Stanton and other women's rights activists who lived in and traveled through Seneca Falls.

The map, which highlights routes to and from the Elizabeth Cady Stanton House, shows visitors how far they've walked and approximately how many calories they've burned.

Along the way visitors can also get information about the Seneca Falls Historic District and other area museums. "We're really excited to share this map as both a learning opportunity and a way to get people moving outdoors," said outgoing HP-squared chair Andrea DeKoter. ## WE-R-WORI Empowers Staff

Since its creation this past fall, WE-R-WORI, an acronym for "Workforce Enrichment – Women's Rights National Historical Park," has been busy drafting a mission statement and developing activities aimed at making Women's Rights National Historical Park an enjoyable place to work.

WE-R-WORI, developed a mission statement that summarizes the goals of the committee and the park: "WE-R-WORI exists to promote employee wellness, employee empowerment, training and development, awards and recognition, teamwork, and respect. We will educate and work with employees to accomplish

these goals; everyone's voice will be heard. We want people to feel engaged, feel their work is rewarding, and be encouraged to collaborate to make this workplace the best it can be."

Gene Freese, the park's administrative officer and WE-R-WORI's chairperson, distributed the mission statement to park employees. "We have made a great deal of progress, including offering a webinar on improving memory-building skills, preparing for retirement, and enhancing our training library," said Freese. "We want to help every employee at Women's Rights National Historical Park feel empowered."

The NPS Workforce Enrichment initiative resulted from data indicating that a high percentage of NPS employees were frustrated with many aspects of their job. According to a 2011 Best Places to Work in the Federal Government survey, the National Park Service ranked 163th out of 216 federal agencies. Upon becoming Director of the National Park Service, Jon Jarvis declared that one of his goals was to make the National Park Service a top ten federal agency to work for by 2016, the 100th anniversary of the organization's creation. Superintendent Duchesne supports the group and is excited to work with them.
