
APRIL-JUNE, 1986

Wilderness Work Skills Program Rocky Mountain Region S.C.A. Northwest P.O. Box 31989 Seattle, WA 98103

This is a skills development and information exchange program addressing the practical "hands on" aspects of wilderness and backcountry management. Students will be engaged in a comprehensive field work project for the week and will rotate through a series of daily work stations, including:

- * Timber Use and Construction
- * Revegetation and Site Restoration
- * Tread and Drainage Maintenance
- * Rock Structure and Building Techniques
- * Trail Engineering and Design

In addition, these field exercises will be augmented with formal presentations and workshops. Sessions will be from June 8-13 and June 15-20, 1986 at Yellowstone National Park. Fees are \$200 (Resource Agency, Organization, Educational Institution) and \$250 (General). Subject: Relocation Income Tax Allowance Eligibility

Our records indicate that you may be eligible to receive a payment for the Relocation Income Tax Allowance (RITA) as authorized by Public Law 98-151, dated November 14, 1983. RITA is for the reimbursement of the additional Federal, State, and local income taxes as a result of certain relocation expense reimbursements. This applies to employees whose effective date of transfer is on or after November 14, 1983.

The statutory authority for RITA did not make changes to the Internal Revenue Code or State or local tax codes. Therefore, the authority for reimbursement of additional income tax incurred as a result of moving expense reimbursements should not be construed as changing or limiting your income tax obligations in any way or authorizing a refund of these taxes when filing a return with any recognized tax authority.

To receive the new allowance, please complete and send the attached RITA Certification for tax year 1985, along with a signed Travel Voucher, copy of W-2(s), and Internal Revenue Service (IRS) Schedule SE (if applicable). Upon receipt of the necessary forms, the allowance will be calculated and paid to you. A copy of the paid voucher and calculations will be furnished to you for your records. A separate RITA claim is required for each calendar year in which relocation reimbursements are reflected on the W-2. It is the National Park Service policy that RITA claim must be filed by May 15. If a claim is not filed by May 15, action will be taken to collect the total withholding tax allowance (WTA) payments through payroll deduction and/or from any travel amounts available.
