### EDITOR'S NOTE

### WILDERNESS MANAGEMENT

A two-day symposium on fire in wilderness and park management will be held in Missoula, Montana, immediately before the 1993 conference on the limits of acceptable change in the national wilderness preservation system. The purpose of the symposium is to increase knowledge and awareness among wilderness managers, fire managers, and the general public regarding the issues, problems, and capabilities affecting attainment of wilderness objectives with fire management programs. Symposium topics include the evolution of fire in wilderness management, attaining fire and wilderness goals and resolving conflicting goals, political issues in management of fire and wilderness, planning considerations, public information on active fires, and restoration and rehabilitation. During the plenary session, the Honorable Bruce Vento, Chairman of the House Subcommittee on National Parks, Forests, and Public Lands, will address the symposium on the political considerations of park and wilderness management.

The symposium is being sponsored by the NPS, the Forest Service, the Bureau of Land Management, the Fish and Wildlife Service, the Wilderness Society, the National Wildfire Coordinating Group, the Renewable Natural Resources Foundation, the Society of American Foresters, and the University of Montana. ### NOTES FROM THE PARKS

#### Yosemite

On February 22nd, the United States Supreme Court issued a summary reversal of a Ninth Circuit ruling in the United States v. Jerry Nachtigal regarding the right to a jury trial for a person charged with driving under the influence. Nachtigal was arrested on September 20, 1989, for driving under the influence of alcohol and/or drugs after a single-vehicle accident in the Wawona District in which he suffered a number of injuries and had to be extricated from his vehicle. The arresting ranger was Jeffrey Lynn. Nachtigal was scheduled to appear in Yosemite magistrate's court that fall, but the case was twice continued. On January 18, 1990, Nachtigal refused magistrate's jurisdiction and the case was transferred to Fresno. The magistrate there denied Nachtigal's motion for a jury trial, applying the Supreme Court decision in Blanton v. North Las Vegas (489 U.S. 538, 1989). On appeal, the district court judge reversed the ruling. The case was appealed to the Ninth Circuit, where a panel of three justices affirmed the district court's ruling in an unpublished opinion. The United States again appealed, this time to the Supreme Court, and was granted relief in an unprecedented summary judgement petition for writ of certiorari, with no dissenting justices. The court wrote: "We hold that the Court of Appeals was wrong in refusing to recognize that this case was controlled by our opinion in Blanton, rather than by its previous opinion in Craner. An individual convicted of driving under the influence in violation of 36 CFR 4.23(a)(1) (1992) is not constitutionally entitled to a jury trial. The petition of the United States for certiorari is accordingly granted, and the judgement of the Court of Appeals is reversed." #### Golden Gate

On February 19th, a hearing was held in U.S. District Court in San Francisco on whether or not to grant the Bicycle Trails Council of Marin (BTC) an injunction against the Service enforcing its newly promulgated special regulations while BTC pursues its lawsuit against the regs. During the hearing, Judge Eugene Lynch posed the following question to the BTC attorney, who's also an avid mountain biker: "Is there nowhere else to ride in Northern California?" Judge Lynch declined to grant the injunction and ruled that the Service could begin enforcing the law. Rangers accordingly began enforcing the regs throughout the park. On the first day, March 6th, they issued for citations for possession of bicycles on non-designated routes under 36 CFR 7.97(c). The bail schedule calls for \$25 fines for exceeding speed limits and \$50 for failure to possess or use lights after dark.
