SIGNIFICANCE (architectural and historical, include original use of structure) NPS Landscape Architect Francis G. Lange described the Administration Building in his final field report for 1935 as "one of the most attractive structures of its kind in any of our national parks." It is the keystone of the group of rustic stone structures built at Crater Lake's administrative head- quarters from 1926-1935, exemplifying in its use of native materials, colors and forms that harmonize with its environment, the principles of the rustic style of park architecture developed STYLE (if appropriate) by the NPS' San Francisco Branch of Plans and Designs. 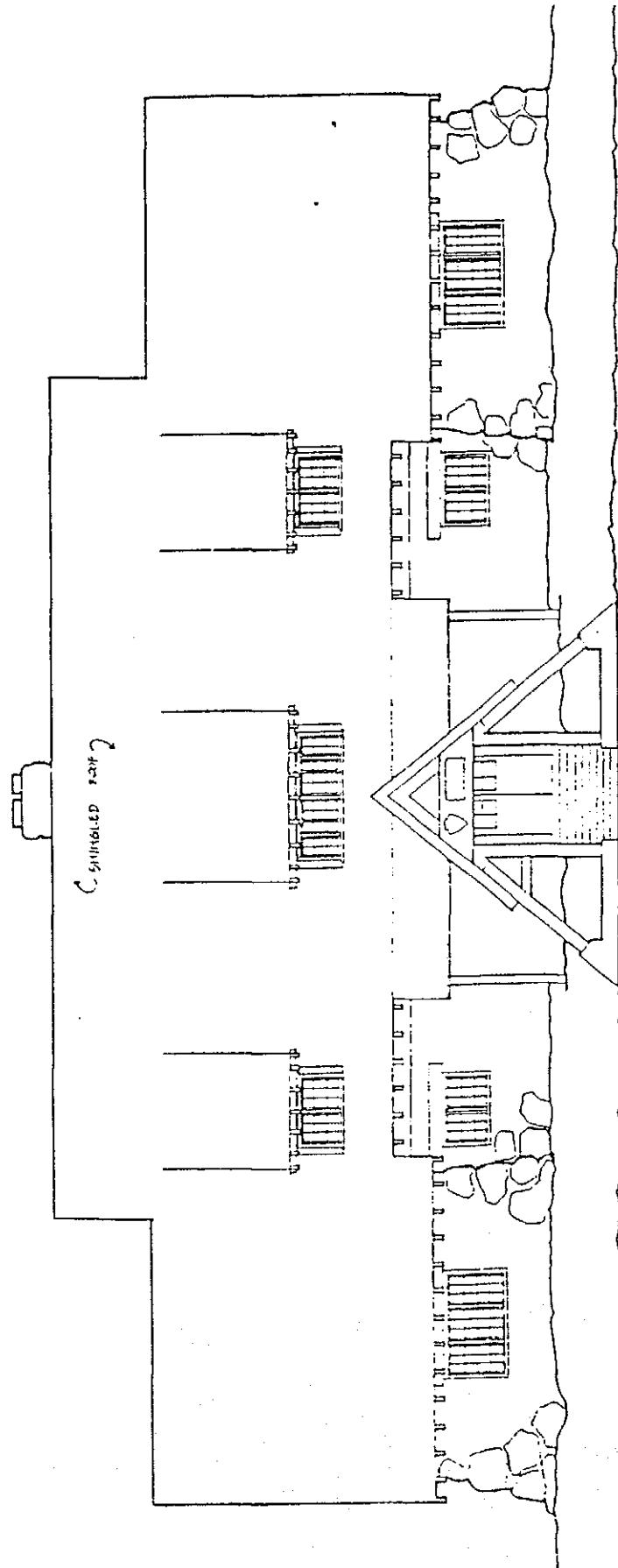
EXTERIOR FEATURES OF NOTE

1-½ stories with partial basement; steeply-pitched gable roof with extended eaves supported by squared outriggers; gable-roofed extensions off east and west elevations are set back on north elevation but nearly flush with main section on south; wood-shake roof; shed-roofed dormers on south and north; native boulders used on lower exterior; horizontal wood siding at gable ends; wood shingle siding on dormers; cut stone central chimney on north slope; main entry on south has tri-partite multi-paned fixed sash and french doors; multi-paned metal casement windows throughout; heavy timber lintels above lower level windows; new snow tunnel on west has boulder piers supporting wood-shingled gable roof.

INTERIOR FEATURES OF NOTE (describe floor plans if not sketched)

Prior to the 1986-87 rehabilitation, 1st floor housed a public area, post office, superintendent's office, first aid and restrooms and administrative offices. Interior finishes were 1 x 4 and 1 x 8 T & G V-joint paneling on walls, concrete floor and exposed ceiling beams. Original dark wood moldings were painted in 1970s. Open wood stairway to 2nd floor. Original wrought-iron light fixtures, probably built by E.C.W.- CCC workers are extant. In 1986-87, interior was redesigned, original fixtures and details restored.

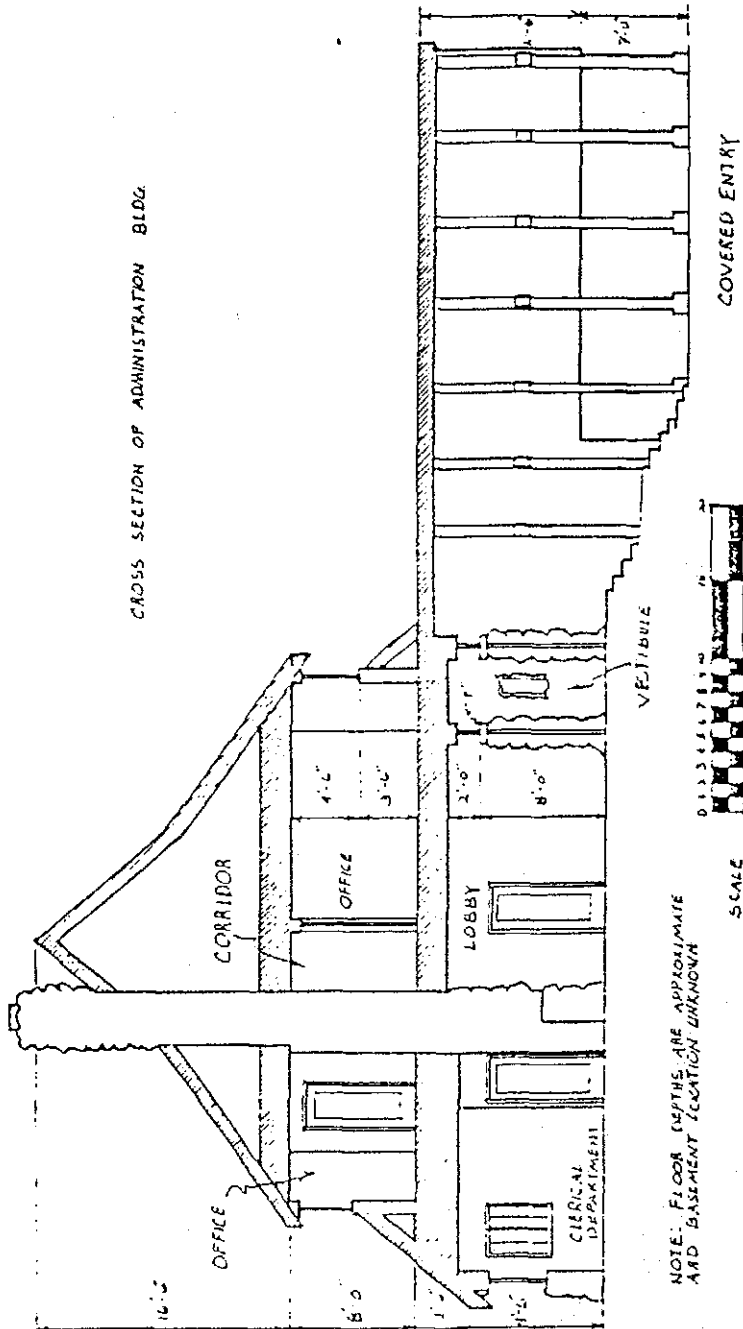
CRATER LAKE ADMINISTRATION COMPLEX, ADMINISTRATION

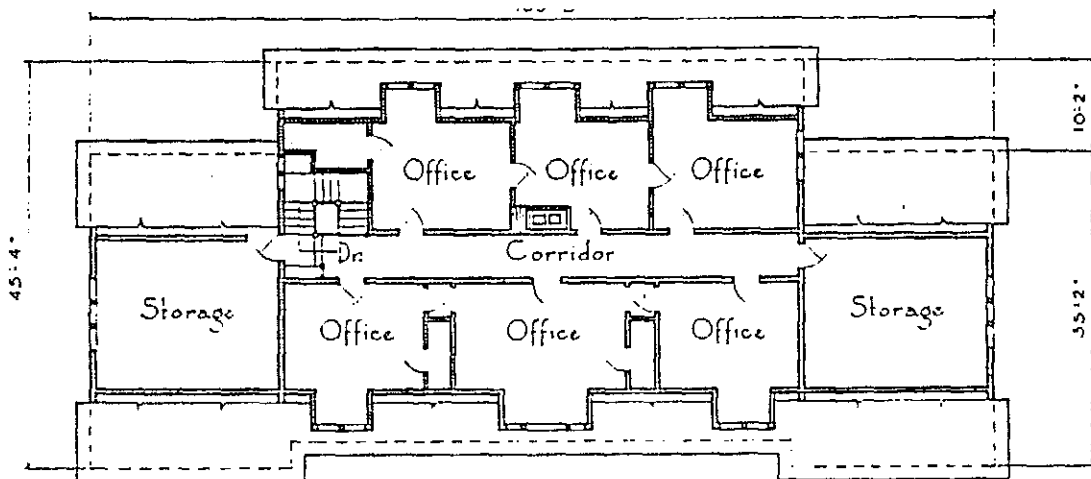

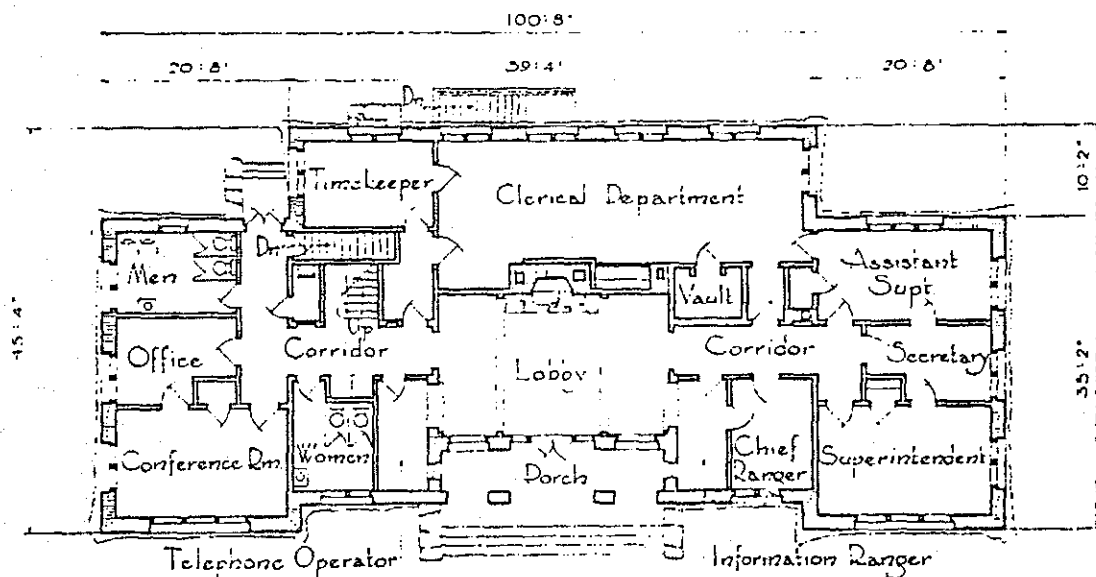

SECOND FLOOR PLAN



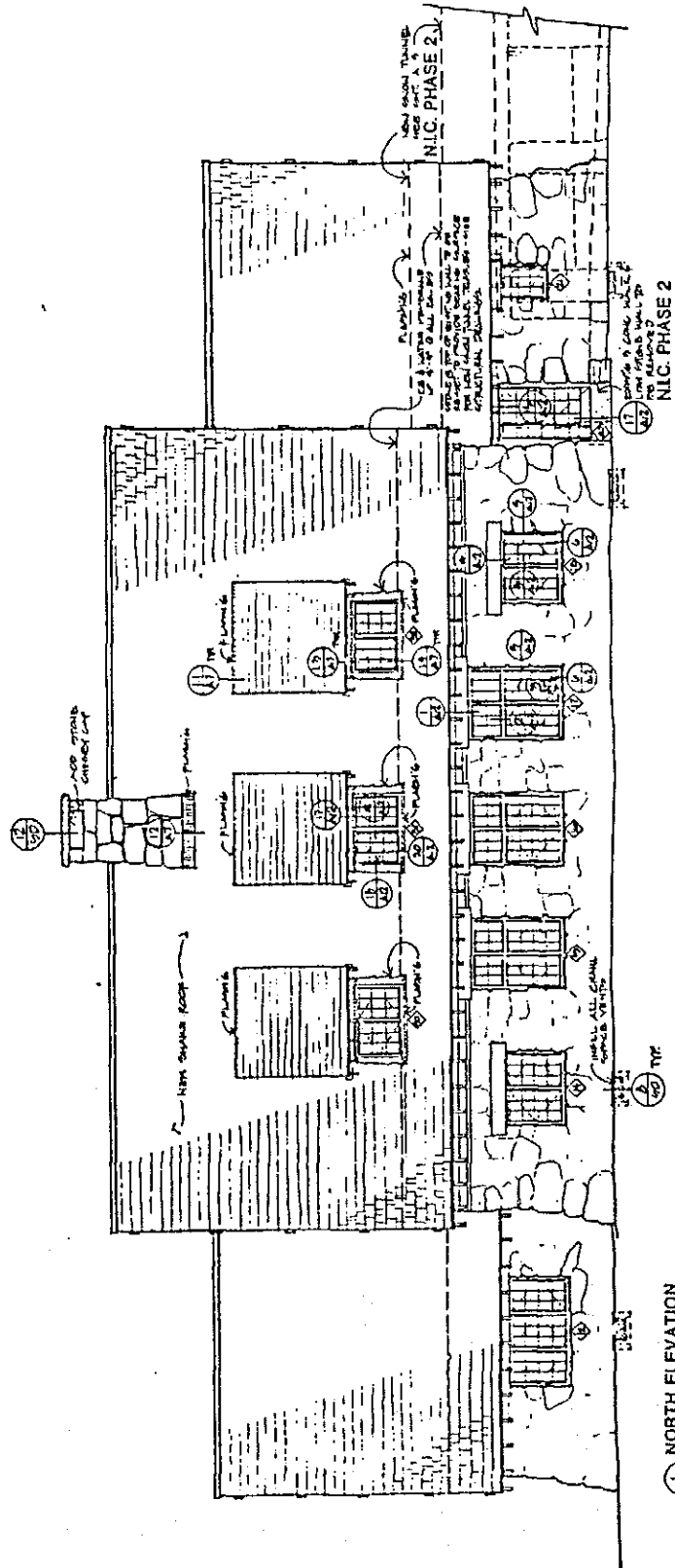
FIRST FLOOR PLAN

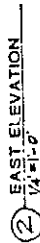

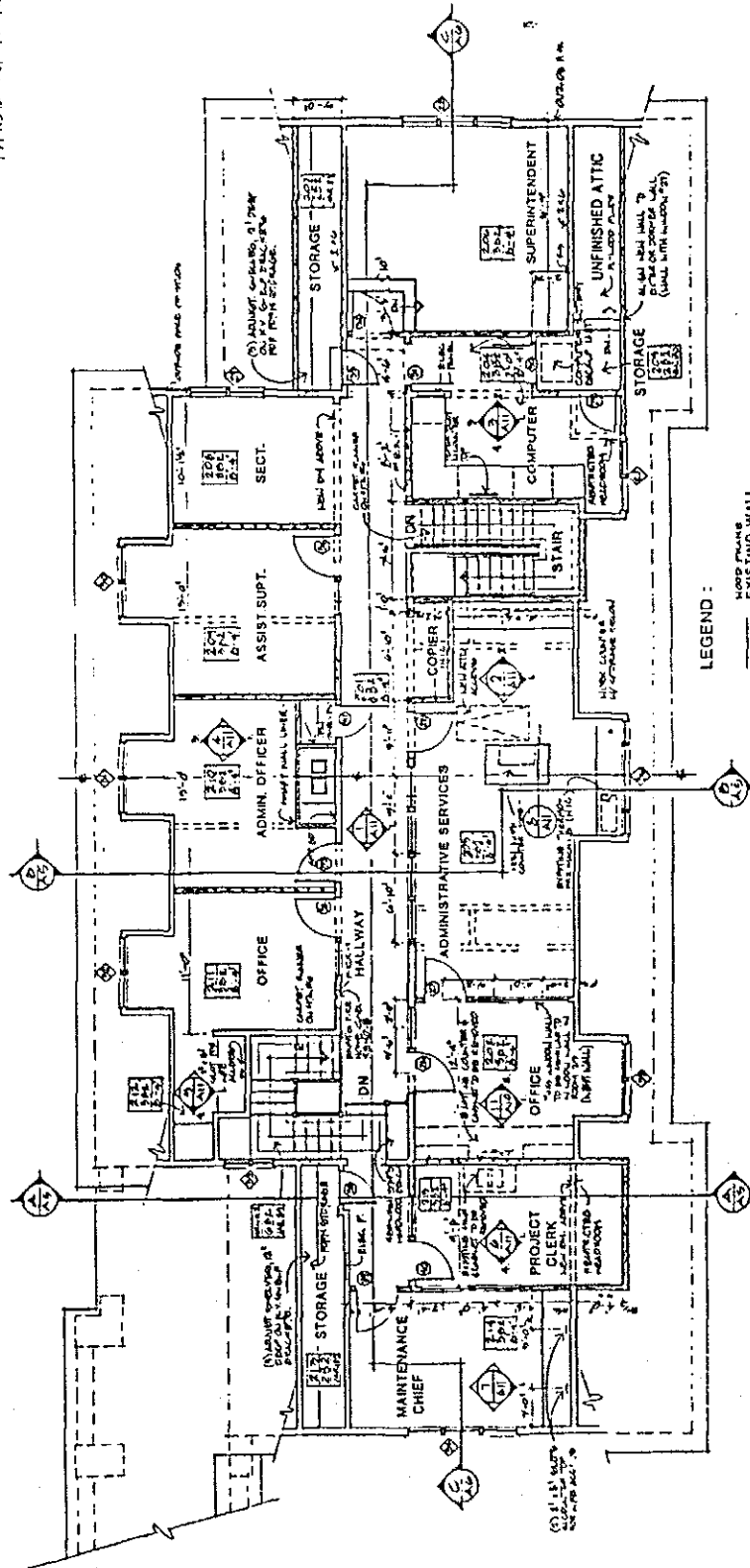
