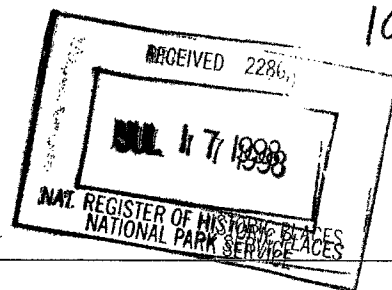

Narrative Description

The Jenny Lake boat concession buildings -- Reimer's cabin, a boathouse, a boat dock, and two employee cabins -- are located in the southwestern corner of the park, on a peninsula of land that extends into Jenny Lake northwest of the outlet of Cottonwood Creek. The site is part of a developed area that includes Crandall Studio and the Jenny Lake CCC complex (housing the climbing concession office and, until 1991, the horse concession facilities). The boat concession buildings sit on the rocky outcrops above the west bank of the creek and the southern shore of the lake, amidst a scattering of pine, fir, aspen, cottonwood, and service berry. The residential buildings are clustered at the southern end of the site; the boathouse is to the northwest, on the lakeshore; and the boat dock branches off a footbridge across Cottonwood Creek. The peaks of Teewinot, Grand Teton, and Mount Owen are intermittently visible through the trees from the cabins. However, the dock and boathouse offer unimpeded views of the mountains across Jenny Lake to the west and north. These buildings can be accessed via the Jenny Lake Trail at the end of a paved entrance road that branches from Teton Park Road. The dirt and gravel Lupine Meadow Trailhead access road from Teton Park Road also provides a rear approach to the buildings.

Reimer's Cabin (HS-0107), constructed 1937

Reimer's cabin is a one-and-one-half-story log building with a gable roof, constructed on a stone foundation. The corners are joined with ventral saddle notches, and the exterior walls are chinked with split poles. At some corners, the log ends are cut at staggered lengths; at others they are cut flush. The frame gable ends are finished with boards and battens, with a decorative cut at the ends of the boards. All exterior wall surfaces are stained or painted dark brown. The gable roof is covered with metal panels, and features an interior concrete block chimney with a ceramic chimney pot

Narrative Statement of Significance**Summary**

Reimer's cabin and the associated boathouse (classified as a "Building") meet the registration requirements established for the Concessioner Complex property types, Grand Teton National Park Multiple Property Submission. (Please see the Park Administration and Development context of the GRTE MPS.) The property's period of significance extends from the 1929 establishment of Grand Teton National Park until the end of the historical period as defined by the National Register of Historic Places, or until the complex is no longer significantly associated with the GRTE recreation network.

The Jenny Lake area was the first to be developed by NPS personnel after establishment of the park in 1929. Even before the park was established, a boat "concessioner" operated on Jenny Lake under a Forest Service Special Use Permit. In a 1929 monthly report, the first park superintendent mentioned the "Wirt" [sic] boat concession, which rented both motor boats and row boats to area visitors." The boat concession was integrated into the first GRTE Master Plans, which recognized the significance of Jenny Lake as a major visitor service area within the park.

Local residents and park staff consistently refer to the boathouse as the Wort boathouse, in reference to first concessioner Charles Wort.¹ In the "Jenny Lake Area Historic Resource Evaluation" NPS historian A. C. Toogood reports "the [boathouse] may have been built by Charles Wort who had the boating concession lease from the U. S. Forest Service."² Park maintenance records, however, indicate that the building was constructed in 1932, by the National Park Service. This post-1929 construction date is supported by NPS landscape architect Philip W. Kearney's report for the E.C.W. - Fifth Period (May 1 to October 15, 1935): "a new Boat House has just been completed on the shore of Jenny Lake for winter storage of boats. The site and design were approved and the structure is inconspicuous and well constructed."³ The exact location of this boathouse, however, is not identified. Regardless of builder or date of construction, the boathouse is significantly associated with concession development along Jenny Lake (criterion A).

By 1935, Robert (Dick) Reimer had assumed the boat concession license. Reimer's new residence (HS-107), completed during the summer of 1937, was constructed under the watchful eye of the Landscape Division, which approved the preliminary drawings and supervised construction. By September of 1937, GRTE Resident Landscape Architect Sanford Hill described the new complex with approval: (See continuation page.)

Verbal Boundary Description

From the boathouse eastward along the north side of the main Jenny Lake Trail to the west bank of Cottonwood Creek southward along the west bank of Cottonwood Creek to the southside of Reimer's cabin thence northward along the path from Reimer's cabin to the boathouse.

Boundary Justification

These boundaries include the two resources that retain historical integrity as well as the paths that link them. The two employee cabins moved to the site during the modern period are excluded as are the modern boat dock and footbridge.

and exposed log rafter ends. All of the windows in the building have wooden sashes, and are trimmed with 5" milled logs. The front (east) elevation contains an open shed-roof porch supported by a foundation of river cobbles. The two corners of the porch roof are each supported by three log columns. Tongue-and-groove boards cover the porch floor. The porch shelters an entry located at the north end of the wall, and one six-by-six-light sliding sash window. The entry contains a double-leaf door made of vertical boards (with one light in the upper leaf) and a wood frame screen door. South of this porch, the east elevation contains two six-by-six-light sliding sash windows, and finally the screened window openings of the rear screened porch that occupies the southeast corner of the building.

On the south elevation an entry into the screened porch is off-set east of center. This entry is flanked on either side by a screened window opening, and is accessed via board steps with a log and milled lumber hand rail. The west end of this wall is enclosed with boards (the area between the top of the wall log and the gable end) has been infilled with boards. (On the interior of the building, this space contains a bathroom.) The gable end is finished with boards and battens; the boards have a decorative cut at the bottom. A four-light casement window (with a wood-frame screen) is centered beneath the roof ridge in the gable end.

The west elevation contains two, six-light by six-light sliding-sash windows in the north two-thirds of the wall. The south third (which corresponds to the interior bath) is covered with permanently affixed shutters. The north elevation contains a centrally placed six-light by six-light sliding sash window centered within the elevation. A four-light casement window is centered within the gable end.

Interior

The living room occupies the north one-third of the main floor of the building. The living room floor is covered with wall-to-wall carpet, that hides hardwood floors. The ceiling consists of the exposed stained and varnished log floor joists of the half-story, and random-width planking (which is painted white). Built-in bookcases are located on either side of the window in the west wall. The south interior living-room wall is finished with rough-cut boards and battens. A large, doorless opening in the east end of this wall leads to the kitchen; a vertical board door in the west end of the wall leads to the downstairs bedroom. The wall, ceiling and floor finishes in the bedroom are the same as those for the living room.

The kitchen floor is covered with linoleum, and the ceiling has the same exposed log floor joists and painted boards as in the living room. The east and south wall of the kitchen are varnished log chinked with split poles; the west wall is finished with rough-cut boards and battens. Cupboards and formica counter-tops are modern. A double-leaf door made of vertical boards leads from the kitchen to the screened porch at the rear of the building. The east and south walls of the screened porch are formed by the exterior bearing walls of the building. The porch floors are covered with the same linoleum as that in the kitchen and the ceilings are the same as those in the kitchen/living-room. An interior wood stairway leads to the half-story, which contains a bedroom at either end with a storage room in between.

Jenny Lake Boathouse (HS-0034), constructed ca. 1930

The boathouse is a rectangular, one-story, log building with a gable roof. The front (north) elevation is supported by log cribs filled with stone that in turn rest on bedrock; the rear foundation is not visible beneath deteriorating sill logs. The corners of the building are joined with ventral saddle notches with flush-cut log ends. Chinking consists of split poles. The front-gable roof is covered with rolled asphalt roofing.

The front elevation contains a small plank deck that projects over the edge of the lake and that is supported by log pilings. The entire width of this elevation contains an entry that has a pair of hinged, plywood doors. (The original doors ran along metal tracks affixed to the interior walls of the building and contained ribbons of windows placed within the upper edge of the door.) The west, south and east elevations each contain a nine-light by nine-light sliding window (with wooden sashes) centered within the elevation. A pedestrian entry is located at the south end of the west elevation, and contains a vertical board door. The door and the windows are trimmed with milled log slabs.

Interior

The interior of this building contains one large room, now used by the boat concessioners, Brent and Chris Miller, for storing supplies. The interior walls and ceiling are unfinished, except for split pole chinking on the interior walls. The floor consists of large 10" - 12" planks.

8. Statement of Significance, continued

"Mr. Reimer . . . has already razed his old office building just off the west end of the foot bridge. The removal of this building has improved the appearance of the area a good deal. He is also going to remove the tent frames from their present location and then the point will be free of all structures except the boat house which is on the lake side and invisible from the trail bridge.⁴

Because of the degree of Landscape Division involvement in site layout and architectural design, Reimer's cabin is a significant example of NPS Rustic Architecture (criterion C).

Of the boat concession facilities currently present at Jenny Lake, only the boathouse and Reimer's cabin date to the historic period and continue to be used in association with the Jenny Lake boat concession. The boat dock, although in the same location as the original boat dock, was reconstructed in 1994 by the current concessioners, Brent and Chris Miller. The Jenny Lake footbridge referenced by Hill was entirely reconstructed in 1981 by NPS crews. In addition, the cabins that house the concessioner's employees do not date to the historic period. Originally, there were three small cabins located nearly adjacent to the west side of Reimer's cabin. However, the boat concessioner removed those buildings sometime during the 1970s or early 1980s, and replaced them with the two current cabins that were moved in from the community of Kelly, Wyoming. Apparently, the park service applied two of the original building numbers to these new buildings. The boat dock, the footbridge, and the two employee cabins are excluded from the boat concession National Register site boundaries.⁵

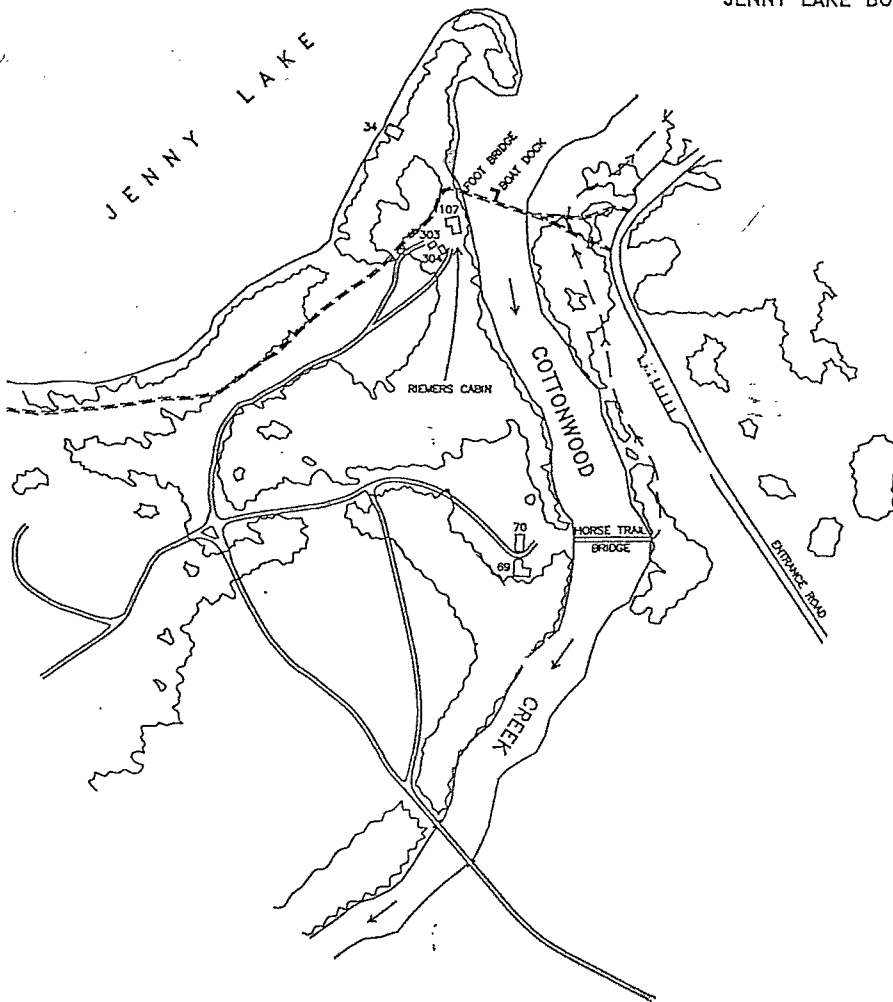

JENNY LAKE BOAT CONCESSION

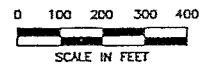


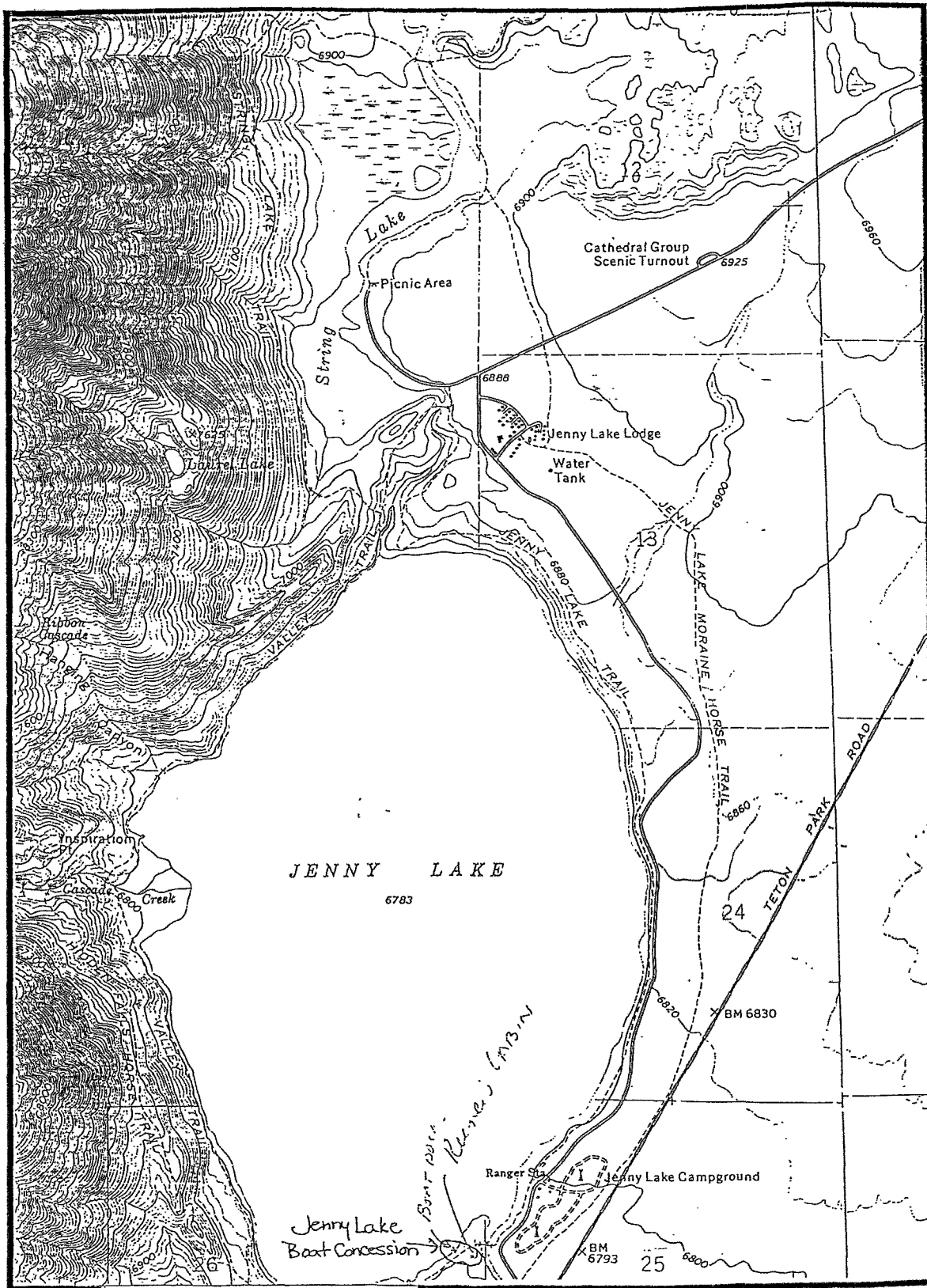
