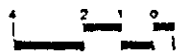
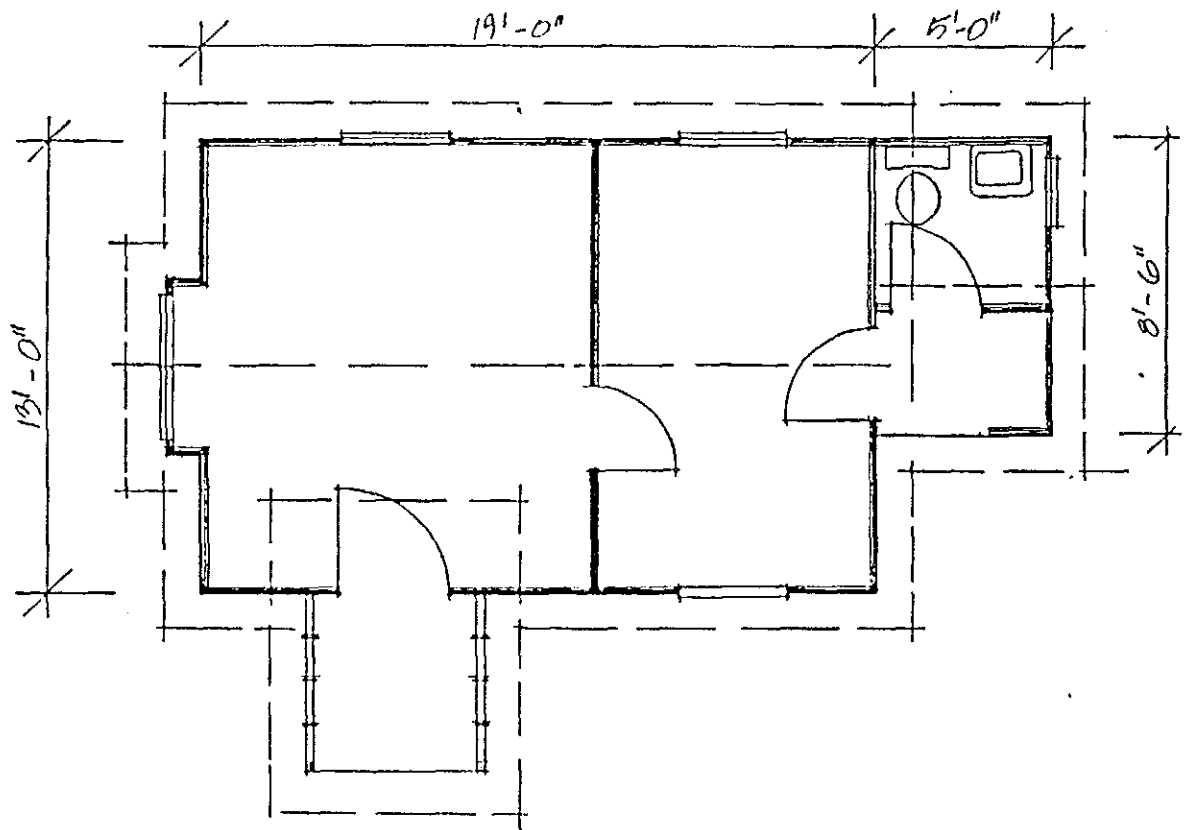

SIGNIFICANCE (architectural and historical, include original use of structure) This cabin was constructed as an integral part of the Rosemary Inn Complex. It contributes to the overall character of the rustic, picturesque resort ensemble and possesses integrity of design, materials, workmanship, location, setting, feeling and association.		
STYLE (if appropriate) Craftsman-style cottage		
MATERIAL OF CONSTRUCTION (include structural systems) Wood-frame construction set on 6 x 6 wood posts on concrete piers and blocks.		
SHAPE AND DIMENSIONS OF STRUCTURE (sketched floor plans on separate sheet acceptable) Irregular: approx. 13' x 19' with a 5' x 9' addition on east facade.		
EXTERIOR FEATURES OF NOTE 1-story; wood-shingled gable roof with exposed rafter ends and slightly extended eaves; shed-roof extension off south facade forms entry overhang supported by peeled logs; wood shingle siding with vertical wood boards at gable ends; hip-roofed bay window on west has tri-partite diamond pane casement sash supported by 3 knee braces; multi-paned casement and hinged sash with plain surrounds; horizontal wood skirting; plain fascia boards; entry has boxed wood shingle rail and lattice as screening.		
INTERIOR FEATURES OF NOTE (describe floor plans if not sketched) Painted floor boards; tongue-and-groove bevelled siding on ceiling; vertical tongue-and-groove painted wainscotting on walls with unpainted horizontal T and G above.		
MAJOR ALTERATIONS AND ADDITIONS, WITH DATES Bathroom (on east facade) may be addition; under rehabilitation (1988)		
PRESENT CONDITION AND USE Fair; Vacant
