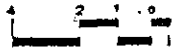
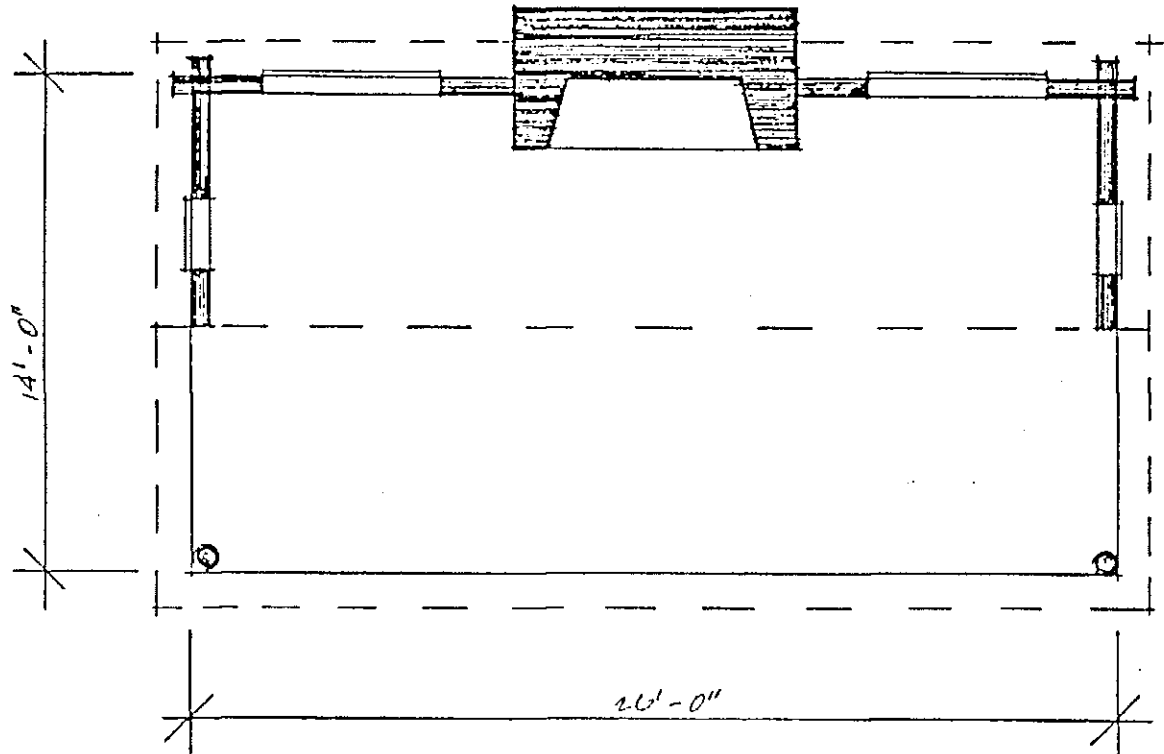

SIGNIFICANCE (architectural and historical, include original use of structure) The Fire Shelter is located near the site of the historic entrance to Rosemary-the lakeshore. Guests originally arrived at the resort by ferry or launch. After the completion of the south shore highway in 1922, access to Rosemary changed and the lakeshore frontage became used exclusively for recreational purposes. The shelter was constructed as an integral part of the complex, contributes to the overall character of the rustic resort, and possesses integrity of design materials.

MATERIAL OF CONSTRUCTION (include structural systems) Saddle-notched log construction set on stone foundation		
SHAPE AND DIMENSIONS OF STRUCTURE (sketched floor plans on separate sheet acceptable) Rectangle: 12' x 18'		
EXTERIOR FEATURES OF NOTE 3-sided shelter: galvanized metal gable roof supported by log posts at open end (south); extended eaves, exposed log rafters and joists, and log fascia; multi-paned fixed sash with plain surrounds; log ends bevelled; vertical board and batten siding on gable ends above logs; massive exterior rough-cut stone chimney and fireplace on north.		
INTERIOR FEATURES OF NOTE (describe floor plans if not sketched) Massive, stepped, rough-cut stone fireplace; flagstone floor; chairs cut from a single log.
