### Archiving Requests

Many of you have green handwritten logbooks, old maps, posters, or other documents lying around in your offices which should be placed in the park archives so that they do not become lost or stolen. In particular, green logbooks are often one-of-a-kind items which contain park information that will eventually be important to historians. They can easily become lost or misplaced. When one of those logbooks is full, it should be sent to the park archives and a new one begun. For law enforcement folks who wish to keep the patrol cabin logbooks available in the cabins for people to read, we can have a copy of it made and sent back to you so that you can do this. Please send the original logbooks to us to be preserved in the archives. Delays often mean lost items. Other paper items are welcome as well. If you have questions about whether or not some documents should be archived, please call me at 2261. If you wish to donate personal Yellowstone documents which were not generated at work, we will take those, too. Like any archives, we can restrict such personal materials from viewing for periods that you specify.

All logbooks (for visitor centers, warming huts, ranger stations, patrol cabins, mountain lookouts, fire records, or anything else) should be sent to the archives when they are full except for the logbooks at the Thorofare Ranger Station (in that unique case, the cabin keeps the originals and we get a copy). ### McKittrick Found Guilty

Chad McKittrick was found guilty on October 25, 1995, of killing, possessing, and transporting a wolf after jury deliberations of less than two hours. McKittrick had been accused of shooting a male wolf near Red Lodge, Montana, on April 24. McKittrick never denied shooting the wolf although he maintained that at the time he fired the shot he believed the wolf was a wild dog, and he felt that the animal could have been harassing livestock and acted "almost rabid." Witnesses testified that McKittrick knew the animal was a wolf before he killed it.

McKittrick could be sentenced up to six months in prison and fined \$25,000 on the charges of killing and possessing the wolf, which are violations of the Endangered Species Act. The maximum penalty for the misdemeanor could be a year in prison and a \$100,000 fine.

McKittrick will be sentenced on the charges after a presentence report has been submitted to the Judge by the U.S. Probation Office, which should be sometime within the next 90 days.

### Book Explores Early Winters in Park

Paul Schullery has worked in Yellowstone as a ranger-naturalist, park historian, consulting researcher, and has published seven books. Schullery's most recent publication is entitled, "*Yellowstone's Ski Pioneers*". "This book is an informal history of the first generations of white people who explored and skied in Yellowstone. It traces our knowledge of the first people to winter over in the area, and talks about winter conditions back then, but mostly it's the story of some really amazing adventures these people had, starting with the first parties to formally explore the park in winter (which happened after a number of locals were routinely traveling the park in the winter) and continuing through the period when the army and the civilian scouts patrolled the park to protect the wildlife." said Schullery.

"I think it's fun because of the adventures, but it's also fun to read how these people lived and worked; their equipment, their clothes, and their attitudes were different from ours. Yellowstone was another world then. Readers can decide for themselves if it was also a better world." All the author's royalties are donated to the Yellowstone Association to go into an account to support park publications.
